**DECISION No. 1079/ 18.03.2025**

**regarding the cancellation of the public auction procedure, announced on 20.02.2025, according to the Auction Announcement no.650/17.02.2025, organized for the concession of three real estate properties (areas/plots of land), located in the Port of the Sulina Free Zone**

The undersigned, *DRAGOȘ IONIȚĂ*, General Manager, legal representative of the Sulina Free Zone Administration R.A., with headquarters in the city of Sulina. Sulina, str. I, nr. 202, county. Tulcea, tel./fac 0256 493936 / 490705, C.U.I. nr. RO 3053425, J36/678/1993; based on the attributions granted by the Decision of the Board of Directors of A.Z.L.Sulina no.603/13.01.2023 and approved by HCJ Tulcea no.13/28.01.2023 and by the Mandate Contract no.135/13.01.2023;

Considering the tender notice no. 650/17.02.2025, having as object the concession of three real estate properties (areas/plots of land), located in the Port of the Sulina Free Zone, as well as the fact that in the first stage of this procedure, until the deadline set - 14.03.2025, 16.00, only one request for participation/letter of interest to participate in the auction was submitted;

Taking into account the report of the Fundraising Manager no. 1066/17.03.2025,

In accordance with the provisions of art.29 para. (2), art. 30 para. (1) and of art.32 of G.D. no.1998/2004 regarding the approval of the Methodological Norms for the concession of public or private property of the state or of the administrative-territorial units, as well as of the public activities/services of national or local interest, under the administration of the free zones,

**DECIDE:**

**Art. 1.** – The public tender procedure announced on 20.02.2025 is cancelled, according to announcement no. 650/17.02.2025, published in the press, on the company's website and in the Official Gazette of Romania part IV no. 832 of 19.02.2025, having as object the concession of three immovable properties (areas/plots of land), located flax Sulina Free Zone Port, motivated by the submission within the first stage of the procedure of only one request to participate in the auction, until the deadline of 14.03.2025, 16.00,.

**Art.2.** – The organization of a new public auction procedure is approved for the concession of three real estate properties (areas/plots of land), located in the Port of the Sulina Free Zone, at a later date determined according to the updated calendar of the auction procedure, with the fulfillment of all the obligations of transparency and publicity established by the normative acts in force.
